1. Introduction

This Coal Combustion Residual (CCR) Rule Report documents that the West Emergency Holding Pond at the Basin Electric Power Cooperative Laramie River Station meets the safety factor assessment requirements specified in 40 Code of Federal Regulations (CFR) § 257.73(e).

The West Emergency Holding Pond is an existing CCR surface impoundment as defined by 40 CFR § 257.53. The CCR Rule¹ requires that periodic safety factor assessments be completed every five (5) years. The initial safety factor assessment for the existing CCR surface impoundment was completed on October 12, 2016.

The owner or operator of the CCR unit must obtain a certification from a qualified professional engineer stating that the periodic safety factor assessment meets the requirements of 40 CFR § 257.73(e).

The owner or operator must prepare a safety factor assessment every five years.

2. Periodic Safety Factor Assessment

40 CFR § 257.73(e)(1)

The owner or operator must conduct initial and periodic safety factor assessments for each CCR unit and document whether the calculated factors of safety for each CCR unit achieve the minimum safety factors specified in (e)(1)(i) through (iv) of this section for the critical cross section of the embankment. The critical cross section is the cross section anticipated to be the most susceptible of all cross sections to structural failure based on appropriate engineering considerations, including loading conditions. The safety factor assessments must be supported by appropriate engineering calculations.

- (i) The calculated static factor of safety under the long-term, maximum storage pool loading condition must equal or exceed 1.50.
- (ii) The calculated static factor of safety under the maximum surcharge pool loading condition must equal or exceed 1.40.
- (iii) The calculated seismic factor of safety must equal or exceed 1.00.
- (iv) For dikes constructed of soils that have susceptibility to liquefaction, the calculated liquefaction factor of safety must equal or exceed 1.20.

An initial safety factor assessment was performed in October 2016. As part of the periodic assessment, an updated analysis has been performed to document that the calculated factors of safety for the West Emergency Holding Pond achieve the minimum factors of safety listed in § 257.73(e)(1)(i) through (iv). The periodic assessment included evaluating multiple cross-sections of existing conditions and performing analyses at the critical (i.e. most susceptible) cross section, based on appropriate engineering considerations and calculations. The analyses used subsurface information collected from historical subsurface investigations and laboratory testing data. Engineering properties for the various material strata were selected based on the results of available field and laboratory data. The results of the safety factor assessment are listed in Table 1.
